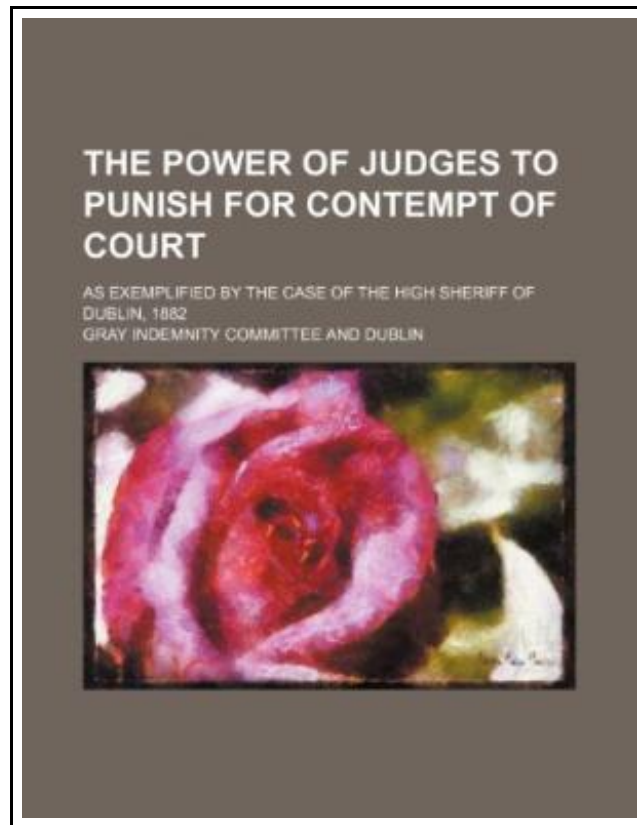

The following refer to Mr. Grays conduct as High Sheriff: --To His Excellency Earl Spencer, K. G. , Lord Lieutenant, and c. , Dublin Castle. Your Excellency--I understand that it is your Excellencys intention to order an inquiry into certain charges against the jury in the case of the Queen against Hynes, made in a letter in the Freemans Journal of the 14th met. For the publication of that letter, and asking an inquiry into these charges, I am now in prison. Your Attorney-General in the House of Commons, your Solicitor-General in public court, the Judge on the Bench, and a section of the public Press, have all sought to fix upon me, personally and individually, as High Sheriff, the responsibility of the custody of the jury in that case. The inquiry must necessarily involve the investigation of this charge against me--a charge which, if substantiated, might entail heavy penalties upon me. I therefore claim, as a matter of justice, to be present at that inquiry, to be represented, if I so desire, by counsel; to have the right to examine and cross-examine witnesses, if necessary; and to get adequate notice of the time of holding same. Of course I am quite willing to attend the inquiry--which I presume will be public and upon oath--in the custody of your jailers. If any technical legal difficulty exists as to my leaving the jail for that purpose, then I respectfully submit...
